Stephanie has agreed to assume the role effective January 1, 2025. Vince Garland moved to nominate Stephanie Romelczyk for the NNSWCD Extension Agent Director position effective January 1, 2025. Bobby Vanlandingham seconded the motion. Motion carried unanimously.
