This is open to students with permanent residency within Lancaster, Northumberland, Richmond, or Westmoreland Counties, who will begin a full-time, first-year college curriculum in natural resource conservation and/or environmental studies. The second scholarship is the The James Edward Minor Ag Stewardship Award. This award is open to <u>full-time undergraduate college students</u> with permanent residency within Lancaster, Northumberland, Richmond, or Westmoreland Counties. Applicants must be enrolled in a collegelevel curriculum in natural resource conservation and/or environmental studies. VIRGINIA AGRICULTURAL COST-SHARE PROGRAM (VACS)

With the new year upon us, everyone is prepping for the upcoming busy season. In the midst of preparing, we ask our farmers to keep these important dates in mind:

- March 15, 2024 begin killing or destroying cover crop
- March 15, 2024 all nutrient management plans are due to the office
- June 1, 2024 last day to kill or destroy cover crop

If you have not reported your planted cover crop acres to Brandon or Aaron, please do so as soon as possible. In October, our office sent out a mass text to producers participating in the VACS program regarding required signatures for Part II paperwork. If you have not signed or are unsure if you have signed or not, give our office a call and we will let you know if you need to come by the office or not. We are trying our best to get all paperwork and office visits completed before planting season begins.



With the planting season in mind, don't forget that we have two No-Till drills available to rent - 2016 Esch Drill and 2018 Great Plains Drill. These drills are perfect for planting or reseeding pastures, hay land, field buffers, wildlife plots, and small acreage fields. There is a minimal charge of \$100.00 due at

rental for the first ten acres planted. After the first ten acres there is a charge of \$10.00 per acre. The amount charged is determined by the acreage meter on the drill. Youth Conservation Camp at Virginia Tech:

"For over 40 years the Virginia Association of Soil and Water Conservation Districts has held a Youth Conservation Camp to get high school aged children interested in agriculture and natural resource conservation. In 2012 I was lucky enough to attend YCC as a camper, and this past summer I was allowed the opportunity to attend camp again, but as a counselor. During the camp we had a wide variety of agricultural education-based activities for the campers to partake in at Virginia Tech and in the surrounding areas. Some of the activities included visiting Claytor Lake State Park to learn about tree identification, Ag BMP's, and electrofishing with DWR; visiting Virginia Tech's Kentland Farm and learning about drones, dairy cow production, livestock operation BMP's, and freshwater invertebrates; visiting Lane Stadium/Worsham Field and learning about turfgrass management; taking a tour of the College of Natural Resources and identifying fish specimens, practicing mindful recycling, and learning how to use GIS/GPS; kayaking on the New River; visiting Virginia Tech's Vet School and learning how to do sutures, give IV's, and pull calves; and hiking the Cascades Falls Trail. For me, the best thing about being a counselor was trying to spark the passion and interest for agriculture and conservation in the campers like I had introduced to me when I attended. Attending camp as a counselor really opened my eyes to how much thought and effort goes into this opportunity for children across Virginia. If you know of anyone in grades 9th-12th who are remotely interested in agriculture, conservation, the environment, I cannot recommend this camp enough. VIRGINIA CONSERVATION ASSISTANCE PROGRAM (VCAP)

In October, Education Conservation Specialist, Lowery Becker, nominated Mr. and Mrs. Stilmar of Northumberland County for the Virginia Conservation Assistance Program (VCAP) Participant Award. In 2019, Lowery started working with Ben and Jane Stilmar on their living shoreline project. They installed 150 linear feet of living shoreline at their home on Barnes Creek, a tributary of the Chesapeake Bay. They went to great lengths to study the tidal ranges, mark unexpected changes and question the makings of a living shoreline. Mr. Stilmar still regularly sends Lowery emails with updates on the living shoreline along with data analysis of how the alterniflora and patens are migrating, their success and how the tides are changing. They have also shared their experience with others. They are always open for a visit and have allowed us to use their shoreline as a training tool for VCAP and SEAS staff. Ben and Jane are welcoming, kind and good stewards of the environment. At the VASWCD annual meeting, Mr. and Mrs. Stilmar were presented with the VCAP Participant





Award and their efforts were recognized in front of all 47 Soil & Water Conservation Districts. We couldn't be more thrilled for the Stilmars in this amazing accomplishment.

OUTREACH

Household Hazardous & Electronic Waste Collection Events:

Richmond County & Northumberland County had their 2023 Fall HHW events this past October. On October 22nd, Richmond County had 51 vehicles come through that brought in 6,148 pounds of household hazardous waste and 1,574 pounds of electronic waste. Out of the 51 vehicles, 13 also brought documents for the Shred-It truck for onsite document shredding and 8 vehicles brought in prescription drugs for proper disposal. On October 28th, Northumberland County had their second HHW event of the year. 178 vehicles came through and brought 14,772 pounds of household hazardous waste and 3,403 pounds of electronic waste. In hopes of growing this event, we partnered with Northumberland County Sheriff's office and provided an option for residents to bring prescription drugs for proper disposal. 18 of the 178 vehicles brought in prescription drugs by the bags! According to Northumberland County Sheriff's Department, 129.3 pounds of prescription drugs was collected between the HHW event and their onsite drop off box. Both events were successful and we look forward to growing each event in 2024. Mark your calendars for the 2024 Household Hazardous & Electronic Waste Collections and keep an eye out for upcoming advertisements. Each event is held from 9:00am to 2:00pm.

Safety First

In early 2023, the NNSWCD Board approved the purchase of an automated external defibrillator (AED) to be placed in the office accompanied with a CPR/AED certified training. After months of various obstacles, the AED finally arrived. In November, a CPR training was led by Calvin Chief of Emergency Services Balderson, Northumberland County. Staff were trained on how to safely administer CPR and properly use an AED if required. We also received a REVIVE training from Alexis Burrell with the Virginia Department of Health (VDH). This training provided the skillset on how to recognize and respond to an opioid overdose emergency with Naloxone. This is a free training for all Virginians by the VDH. As members of the community and an office that consists of field work, it is important and beneficial for our staff to be trained with life-saving skills.

For anyone who was in the office before the new year, you already know we were running full speed to beat deadlines, but we're now finalizing payments for the 2023 growing season and preparing for our new FY24 contract application rankings. We've got a new face on the NRCS side of the office. Karen Balentine joined our team in December as a soil conservationist. Please stop in, say hi, and introduce yourselves! We also have an administrative assistant joining the team in February or March as well. As soon as this is finalized, I'll send a bio for him as well!

There WILL be a second EQIP and CSP application deadline for FY24. That deadline is February 9, 2024. NHQ has changed how we submit some of our applications this year, so this won't apply to ALL fund pools, but it does cover many. If you have any questions about this, please give one of us a call at the office to see if you should submit an application prior to this date. We are still making payments on CSP contracts through mid February. If you have a CSP contract and did not receive your payment in December of 2023, we will be calling you in the next month to come in to sign your paperwork. IF you lost land in your contract, we will have to modify the contract prior to certifying for payment. This takes a week or so to do, so if you know you lost land that was in your contract, please call us soonsowewillhavetimetoaccomplishbothtasksinordertomeetthepaymentdeadlineofFebruary17,2024. If any producer is receiving a nutrient management or precision agriculture payment through any program, we will need a copy of your nutrient management plan (which we can often get from Brandon or Aaron with your approval), your fertilizer records, and potentially yield maps or yield monitor data out of your combines. If you have questions about what we will need, please feel free to call us so we can let you know what to bring before you make a trip to the office. Lastly, NRCS has moved within the USDA office. Because we're running the largest staff we've ever had in Warsaw, we had to get clever with our workspace. Lucee's old office is now the conference room and we've pretty much taken over the north side of the USDA office. When you walk in, you can't miss us, but if you need help finding one of us, just ask FSA and they'll direct you. will another newsletter There probably not be until late spring, hope everyone has а productive AND SAFE planting season!

This year, two Northern Neck farms were nominated for the Virginia Clean Farm Water Award. These awards are eligible to Virginia farmers who implement conservation plans and are doing their part to preserve water quality. Producers spend time, energy and hard-earned money implementing conservation practices. When nutrients and chemicals are kept out of local waterways, quality of life is maintained and improved for many. In the Northern Neck we have two river basins - the Rappahannock River and the Potomac River.

For the Rappahannock River Basin, the Virginia Clean Farm Water Award was presented to Lee and Garnet Sanders of Sanders Farm in Richmond County. The Sanders Family has continuously implemented a no-till planting system, rye cover crops, split side-dress applications, and recently installed a stream exclusion and a large water control structure practice. They are in the process of converting a highly erodible piece of cropland to grass & clover to use for hay under. For the Potomac River Basin, the Virginia Clean Farm Water Award was presented to Robert "Bobby" Vanlandingham of Northumberland County. Bobby has been a steward of conservation for his many years as a Northumberland County farmer, realtor, and NNSWCD Director. He has continuously maintained a no-tillage planting system along with planting rye cover crops on all of his cropland yearly. This summer, he decided to turn his farming operation over to his son-in-law. However, Bobby still plans to remain active in operating equipment and assisting in any way he can. Aaron Saunders, Agricultural Conservation Specialist, recognized both recipients. Unfortunately, Bobby could not join us at the holiday dinner so Chairman, Robert Pickett, accepted the award on Bobby's behalf. Congratulations to both recipients on their efforts to keep our local waterways clean and protected.
